## **Pre-trial Conference:**

## Day Bench/Jury Trial:

Jury bond shall be set in the amount of (\$5,000.00 for the first day and \$1,000.00 for each day thereafter.) The moving party shall post the jury bond seventy-five (75) days prior to trial. If the moving party fails to post bond timely, any other party may post within 10 days thereafter.

Jury charges and verdict forms are to be filed with the Clerk of Court no later than 20 days prior to trial and submitted to the Court on a flash drive in Word format the same day. Objections to opposing counsel's jury charges are to be filed with the Clerk of Court no later than 15 days prior to trial and submitted to the Court on a flash drive in Word format the same day. Trial Notebook due 15 days prior to trial.

**PLEASE NOTE**: Upon filing of the pretrial order the parties shall request a pretrial status with the Court. All attorneys are required to attend the pretrial conference by telephone or by video conferencing and certify that mediation and/or compromise attempts have been exhausted; that ALL preliminary matters are complete and that the matter is ready for trial.

Attorneys must notify the Court via fax 225-389-5327 and/or email Judge Johnson's law clerk, Chelsea Zachary at <a href="mailto:cgarin@19thjdc.org">cgarin@19thjdc.org</a> immediately upon any settlement or compromise of this case, any joint request for cancellation or continuance of any status conference or scheduled Court appearance. The notification for the cancellation or continuance SHALL be made jointly or contain a verification that opposing counsel has no objection.
